Cabinet RESOLUTION NO. (15) of 2017 on The Service Fees and Administrative Fines in the Ministry of Human Resources and Emiratisation

The Cabinet.

- HAVING REVIEWED THE CONSTITUTION,
- FEDERAL LAW NO. (1) OF 1972 ON THE COMPETENCIES OF THE MINISTRIES AND POWERS OF THE MINISTERS AND ITS AMENDMENTS,
- FEDERAL LAW (8) OF 1980 AND ITS AMENDMENTS GOVERNING LABOR RELATIONS,
- FEDERAL LAW NO. (1) OF 2011 ON PUBLIC REVENUES OF THE STATE,
- FEDERAL DECREE-LAW NO. (14) OF 2016 ON ADMINISTRATIVE VIOLATIONS AND PENALTIES IN THE FEDERAL GOVERNMENT,
- CABINET RESOLUTION NO. 25 OF 2010 ON INTERNAL WORK PERMITS APPLICABLE IN THE MINISTRY OF LABOR, AS AMENDED,
- CABINET RESOLUTION NO. 26 OF 2010 ON THE CLASSIFICATION OF ESTABLISHMENTS GOVERNED BY THE LABOR LAW AND THE BANK GUARANTEES APPLICABLE THERETO, AS AMENDED,
- CABINET RESOLUTION NO. 40 OF 2014 ON THE FEES OF SERVICES RENDERED BY THE MINISTRY OF LABOR AND
- AT THE PRESENTATION OF THE MINISTER OF FINANCE, AND THE APPROVAL OF THE CABINET,

Has decided:



Definitions

In the application of the provisions of this Decision, the following words and expressions shall have the meanings assigned against each, unless the context requires otherwise:

State: United Arab Emirates

Ministry: The Ministry of Human Resources and Emiratisation

Establishment: Every economic, technical, industrial or commercial unit where workers are employed, aiming at producing or marketing goods or providing services of any kind and is governed by Federal LAW NO. 8 of 1980 referred to above.

Category: categories used to classify establishments in Cabinet RESOLUTION NO. 26 of 2010 referred to above.

Article 2

- a- Fees shall be charged for the following services rendered by the Ministry, as provided for in the schedules attached herewith:
 - 1. Registration of establishments.
 - 2. Work permits inside the state.
 - 3. Work permits outside the state.
 - 4. Work assignment permits outside the state.
 - 5. Renewal and amendment of work permits and contracts.
 - 6. Workers' work for a new employer.
 - 7. Special recruitment agencies.
 - 8. Support service workers category.

- b- The following fees shall be charged for the services rendered through the systems of the Ministry:
- c- The Minister, or his authorized person, shall determine the services under each of the categories referred to in item (b) of this Article.

Article 3 Administrative Fines

Grievances

An interested person may submit a written grievance to the Ministry regarding any of the administrative fines referred to in Article 3 hereof imposed against him, within ten (10) business days from advising him of the grieved decision, provided the said grievance must be reasoned and supported by all the required documents. A decision shall be issued regarding the grievance within twenty (20) days from the date of its submission, according to the Ministry's applicable procedures.

Article 5

Revenue Allocation Agreement

An agreement was concluded between the Ministry and the Ministry of Finance to allocate a part of the fees charged for the services referred to in Article 2(b) hereof to develop the Ministry's systems and services, as well as to determine the share of service providers for the services they render.

An establishment shall be exempted from the fees referred to in Article 2(a) hereof, if:

- a- It is a fishing boat.
- b- The fees are chargeable on the establishment due to its employment of an Emirati or GCC citizen.

Article 7

Exemption from Administrative Fees and Payment in Instalments

The Minister may decide exemptions and payment in instalments of the administrative fines referred to in Article 3 hereof, provided such exemptions and the mechanism of their payment in instalments, including the required conditions, controls and procedures, shall be determined by a decree to be issued by the Minister in coordination with the Ministry of Finance for this purpose.

Article 8

Settlement of Administrative Fines

All administrative fines due on an establishment (subject to a maximum of AED 2,000 per worker) for its failure to issue or renew the labor card shall be settled, if such fines are due before the effective date of Cabinet RESOLUTION NO. 40 of 2014 referred to above, or if they result from the committing of any of the violations provided for in Article 3(1) –(4) thereof.

Article 9

Amendment of Administrative Fees and Fines

The Cabinet may amend the administrative fees and fines provided for herein though addition, deletion or modification.



Collection of Administrative Fees and Fines

The administrative fees and fines provided for herein shall be collected through the methods decided by the Ministry of Finance in this regard.

Article 11

General

- a- For the purposes of collecting the administrative fees and fines set out in Articles 2 & 3 hereof, a part of a day shall be regarded as a day and a part of a month shall be regarded as a month.
- b- The Minister shall determine the conditions, controls and standards of services and violations set out herein.
- c- The Minister shall determine the controls and procedures regulating the conclusion and renewal of employment contracts and the terms, guarantees and details they must contain, according to applicable law in the state.
- d– The Ministry, and any entity authorized by it, may conclude contracts with any public and private establishments and companies to provide any of these services.
- e- The Ministry shall collect the financial guarantees required for the transactions of supportive labor category, by a decree to be issued by the Minister in coordination with the Minister of Finance for this purpose, provided the said decree shall provide for the conditions and controls of collecting these financial guarantees and the exemption therefrom.
- f- The Minister of Finance, in coordination with the Minister, shall raise an annual report to the Cabinet on the revenues and financial allocations for the development of the Ministry's systems and services.

Issuance of Executive Decisions

The Minister shall issue the executive decision required to enforce the provisions hereof.

Article 13

Transitional Provisions

The provisions of service fees provided for in Cabinet RESOLUTION NO. 40 of 2014 referred to above shall remain effective for six (6) months of the date of publishing this Decree in the Official Gazette, provided the said Resolution shall be cancelled after the said period. Moreover, any and all provisions to the contrary of or in conflict with this Decree shall be cancelled.

Article 14

Entry into Force

This Decree shall enter into force from the date of its issuance, except for the following:

a- The administrative fines set out in Article 3(18), (24), (25) and (26) hereof shall enter into force 45 days from the date of its publication in the Official Gazette.

Article 15

Publication

This Resolution shall be published in the Official Gazette.
